

The Educational Trust

The Desk and Derrick Educational Trust (ET) was created in 1982 by the Association of Desk and Derrick Clubs (ADDC) for the purpose of awarding annual scholarships. All scholarships are made through accredited colleges and universities offering degrees, such as geology, chemical and petroleum engineering. The number and amount of the scholarship awards vary from year to year and are available to eligible full-time students and ADDC members who are part-time students.

Eligibility

To be eligible for a scholarship from the Desk and Derrick Educational Trust, applicants must meet the following criteria:

- At least two years or currently enrolled in the second year of undergraduate study at an accredited college or university.
- Grade point average of 3.2 or above on a 4.0 grading system (U.S.) or 80% (Canada).
- Financial need.
- Career in petroleum, energy or allied industry.
- Citizen of United States or Canada.


TAX DEDUCTIBLE
